5.2 **Programme of Future Works**

North of Limestone Road – out to tender mid-end August for works commencing early September.

Tenders received for 2 steelwork pile structures – work to hopefully commence early September.

PD – Asked for a way to send out programme/spread sheet showing status of works/phasing plan.

- JB to organise by end of week.
- JB Advised of failing control structure wanting opinion on repair or replacement.
- MB Advising £6,000.00 has been put forward from NLWT which could be used towards repair/replacement of failing structure.
- JB Advised money saved on Thorne & Goole could also be put towards this repair/replacement.
- PD Asking regarding timescale for works.
- JB End of October.

6. Financial

JB – Advised this is controlled by Craig Benson on behalf of the Doncaster East IDB. There has been very little change from previous meeting. The £1.2 million will be spent in this financial year. This will leave completion of works in the next financial year.

A construction spend profile is to be issued.

7. Works Information

7.1 **Proposed pumping station:**

Two options for the type of pump have been put forward, axial flow and screw types.

JB indicated that a screw pump was likely to be the preferred option due to the following:-

- Less civil engineering work being required.
- Potential to use a wind turbine to generate some of the power requirement with a diesel generator being the main power supply.
- A screw pump will require less maintenance and attention.

Natural England will be able to obtain funding up to 12,00.00 euros to contribute towards the cost of a wind turbine.
